ORDINANCE

AN ORDINANCE ANNEXING TO THE CITY OF RUSSELLVILLE, LOGAN COUNTY, KENTUCKY, THREE CERTAIN TRACTS OF UNINCORPORATED LAND AND TERRITORY IN LOGAN COUNTY, KENTUCKY, ADJOINING THE PRESENT BOUNDARY AND CORPORATE LIMIT LINE OF THE SAID CITY.

WHEREAS, at a regular adjourned meeting of the City Council of the City of Russellville, Logan County, Kentucky, held at the City Hall of said City on the 18th day of Movember, 1969, an ordinance was enacted by the City Council of said City entitled "An ordinance proposing to annex to the City of Russellville, Logan County, Kentucky, three certain tracts of unincorporated land and territory in Logan County, Kentucky, adjoining the present boundary and corporate limit line of said City." and said ordinance having been published according to law, and an "Ex Parte Complaint" having been filed by said City in Logan Circuit Court on December 10, 1969, and notice having been given of the filing of said "Ex Parte Complaint" according to law, and the time having expired in which any protest or remonstrance could be filed by any person and no protest or remonstrance having been filed thereto, and the Judge of the Logan Circuit Court on March 9, 1970, having signed the judgment authorizing said City to annex said territory herein described and the Clerk of the Logan Circuit Court having entered said judgment on March 9, 1970, and having certified said judgment to the City Clerk of said City on March 9, 1970, and said judgment having been entered on the Record Book of said City as Exhibit "A" to the minutes of the regular meeting of the Russellville City Council on Tuesday, March 17, 1970.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RUSSELLVILLE, KENTUCKY:

That there shall be annexed to and shall become a part of the City of Russellville, Kentucky, three tracts or parcels of land, which adjoins the present boundary and corporate limits of said City, same being more particularly described as follows, to-wit:

PARCEL NO. 1:

Beginning in the South right of way line of Kentucky Highway No. 100 at a concrete marker where the present City limit line intersects the said right of way line, thence with the South right of way line of said Highway as it meanders S 42 E 100 ft., S 45 E 100 ft., S 49 E 100 ft., S 52-1/2 E 100 ft., S 54 E 100 ft., S 55-1/2 E 615 ft., S 55 E 100 ft., S 53-1/2 E 100 ft., S 51 E 100 ft., S $47\frac{1}{4}$ E 100 ft., S 44 E 100 ft., S 42 E 115 ft., thence leaving said Highway N 37-1/2 1370 ft., to a point in the South line of Rohrer, also a corner with Hatchett and Graham, thence N 63-5/6 W 1900 ft. to a point in the Rohrer and Bouldin line, thence with the Rohrer and Bouldin line S 66-3/4 W 470 ft., thence with same S 47-38/60 W 85 ft., to a point in the present City limit line established in 1959, thence with said line due South 560 ft. to the point of beginning, and containing 48.34 acres.

PARCEL NO. 2:

Beginning at the present Northwest corner of the City limits of Russellville; thence due west 25 ft. to a stake in the line of Floyd Wilhelm; thence S 65 W 510 ft. with the line of Wilhelm to a stake, a corner with Wilhelm; thence S 84-1/2 W 3087 ft., with the line of Wilhelm to a rock, corner with Wilhelm; thence S 21-1/2 W 1472 ft. with the line of Wilhelm to a stake, a corner with Wilhelm and the Sportsman Club Subdivision; thence S 45 E 1221 ft. with the line of the Sportsman Club Subdivision to a stake; thence with same S 72-1/2 E 83.7 ft. to a stake, a corner with the Sportsman Club Subdivision; thence \$7-1/4 E 279 ft. to a stake in the west right of way line of the Sportsman Club Road; thence S 20-1/2 E 2300 ft. with the west right of way line of the Sportsman Club Road to a stake in said right of way line; thence N 78 E 2410 ft. to the present City limit line established in 1959; thence due North 4,070 ft. to the beginning, containing 309 acres.

Beginning in the North right of way line of U.S. Highway #79 at a concrete marker where the present South City limit line intersects same; thence with the North right of way line of said Highway 5 calls, S 41 W 1614 ft. to a stake, thence S 44 W 356 ft. to a stake, thence S 46-1/2 W 262 ft. to a stake, thence S 49-1/2 W 213 ft. to a stake, thence S 51-1/2 W 1921 to a stake; thence at a right angle S 38-1/2 E 70 ft. to a point in the South right of way line of U.S. Highway #79; thence with the South right of way line of said highway five calls, N 51-1/2 E 1921 ft. to a stake, thence N 49-1/2 E 213 ft. to a stake; thence N 46-1/2 E 262 ft to a stake; thence N 44 E 356 ft. to a stake, and thence N 41 E 1675 ft. to a point where same intersects the present South City limit line; thence due West with the present South City limit line; thence due West with the present South City limit line 93 ft. to the beginning, containing 7 acres.
