ORDINANCE 78-1 TO CREATE A BEAUTIFICATION COMMISSION TO BE KNOWN AS THE RUSSELLVILLE COMMISSION: TO APPOINT THE MEMBERS THEREOF AND TO DEFINE ITS OBJECTIVES AND DUTIES.

#### BE IT ORDAINED AND ENACTED:

Section I.

## PURPOSE OF RUSSELLVILLE BEAUTIFICATION COMMISSION

Be it ordained by the City Council that the purpose of this Beautification Commission shall be to develop a Comprehensive Beautification Program for the City of Russellville and its environs. This Commission is further charged with the administration of the Beautification Program and the ultimate achievement of its stated goals. The Commission will act as a clearing house for assisting property owners by providing all available information and any available technical assistance pertaining to the implementation of the Beautification Program and will initiate independent activities in the administration of the program. The Commission will promote the development of an incentive for public, residential, and commercial property owners in order that they may participate individually in the beautification of all structures, properties and the conservation of the natural resources in the community.

## Section II.

POWER AND DUTIES OF COMMISSION

Be it further ordained by the City Council that the Beautification Commission be, and it is hereby, granted the authority and responsibility of developing the Comprehensive Beautification Program within the City of Russellville with such general powers and authorities as may be necessary in carrying out the functions of this operation are hereby granted to said Commission.

# Section III

# POWER UPON WHICH THIS ORDINANCE IS BASED

Be it further ordained that this ordinance and the powers and duties set forth herein are based upon police power of the City of Russellville, Kentucky, upon which it inherently has the right to control matters of public health and interest, it being a matter of common knowledge that beautifying the community is a matter that involves the general health and welfare of the community.

## Section IV

## OTHER ENABLING LEGISLATION

Be it further ordained that such further enabling legislation as may be required to properly operate, finance and maintain a Beautification Program for the community will be enacted after due consideration and at the proper time.

#### Section V

### ASSUMPTION OF OBLIGATIONS

Be it further ordained by the City Council that the Beautification Commission shall assume all the obligations and responsibilities at the earliest possible date.

# Section VI

## MEMBERSHIP

The Commission shall be composed of a total membership of seven (7) persons representative of the community.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of Russellville, Kentucky, that the following named persons appointed by the Mayor of the City of Russellville be hereby confirmed and ratified as regular members of the Beautification Commission to serve a four (4) year term all of which will commence 3 January 1978, and expire on January 3, 1982. On the January 3 in which the four-year term expires, the Mayor will appoint seven(7) persons to serve the next four (4) year term. This will be an on going process. These seven (7) persons will be selected from a list of twelve (12) persons recommended by the preceding Beautification Commission.
