

C. Trucks:
1/2 ton \$ 7.00 per hour
1 ton \$15.00 per hour
1 1/2 ton \$20.00 per hour

D. All service pumps: \$8.00 per hour

(2) For the purposes of computing actual costs as defined in Section 2 thereof, the following rates shall apply to materials: Actual cost to City plus ten per cent (10%) thereof to cover breakage, labor loading and unloading, etc.

The rules and regulations shall apply immediately upon their adoption.

Passed by roll call vote, this 19th day of June, 1979.

The motion was duly seconded by Ken Smith and on roll call vote by those present, same passed unanimously.

Willie Hampton made a motion to adopt the following Ordinance No. 79-10 regulating water and/or sewer line installation and/or extensions by Private Contractors Within the City of Russellville. This ordinance reads as follows:

ORDINANCE NO. 79-10

AN ORDINANCE REGULATING WATER AND/OR SEWER LINE INSTALLATIONS AND/OR EXTENSIONS BY PRIVATE CONTRACTORS WITHIN THE CITY OF RUSSELLVILLE.


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RUSSELLVILLE THAT:

1. All private contractors or other individuals or entities proposing to construct water and/or sewer line installation and/or extensions in the City of Russellville shall prior to commencement of work submit detailed plans and specifications and evidence of liability insurance coverage for the period of construction to the City Clerk (or his/her designee), hereinafter referred to as Clerk, for approval by the Superintendent of Public Works of the City of Russellville, hereinafter referred to as Superintendent. The Superintendent's approval should be indicated by the work "approved" followed by the date and his signature. The approval shall be invalidated by the failure of the contractor to commence work within sixty (60) days from that date.
2. The Contractor shall cause the Superintendent (or his/her designee) to inspect the project prior to, during and after construction and shall make such alterations as required by the Superintendent.
3. It shall be the responsibility of the contractor and the person with whom he has contracted, to cause any easements, or other instruments, requested by the City, to be executed to the City and delivered to the City and recorded, at no cost to the City, unless any cost is approved by the City Council.
4. Any person violating any provision of this Ordinance shall upon conviction be fined no more than \$1,000.00.
5. Use of water and/or sewer lines may be withheld to enforce the provisions of this Ordinance. Any decision in this regard may be made by the Clerk.
6. The City Council may adopt rules and regulations to implement this Ordinance.
7. The provisions of this Ordinance are severable, and in the event any provision hereof is or becomes invalid for any reason, such invalidity shall not affect the validity of any other provision hereof.

Any prior Ordinance, or other rule or regulations, or amendment thereto, in conflict with or inconsistent with any provision(s) hereof, are hereby repealed to the extent of that conflict or inconsistency only.


8. This Ordinance shall become effective upon its passage and publication according to law.



Edie Martin moved to go into Executive Session, to discuss Park personnel matters, seconded by Ken Smith, passed unanimously.


Gary Woodlee moved to go out of Executive Session, seconded by Harold Johns, passed unanimously.
