AN ORDINANCE PROPOSING TO ANNEX AND PROVIDING FOR THE COMPLETION OF ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF RUSSELLVILLE, LOGAN COUNTY, KENTUCKY, IN ACCORDANCE WITH THE KENTUCKY REVISED STATUTES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RUSSELL-VILLE, KENTUCKY:

1. That certain real property, described by metes and bounds as follows, shall be annexed to and become a part of the City of Russellville, Logan County, Kentucky:

A certain tract of land located on the west side of the present city limits of Russellville, Kentucky and further described from a survey made May 14, 1979, by E. T. Riley, Land Surveyor, Ky. Reg. No. 128, as follows:

Beginning at the northwest corner of the present city limits, a corner to Floyd Wilhelm; thence with the present city limits and Floyd Wilhelm's line S 21° 25' W 1453.0 ft. to a stake corner to Wilhelm, Les Engler and the Sportsman Club Subdivision; thence with the said subdivision, and the present city limits S 45° 00' E 1221.0 ft., S 72° 32' E 83.8 ft. and S 07° 15' E 279.0 ft. to a monument on the west side of the Sportsman Club Road; thence with the present City limits along the west side of the Sportsman Club Road S 19° 17' E 2311.9 ft. to a monument; thence leaving said road crossing the land of James Meade S 02° 55' W 1264.6 ft. to a post in the north right of way line of Ky. Hwy. No. 178, in the line of the present City Limits; thence with North right of way of Ky. Hwy. 178 N 78° 40' W 1210.0 ft. to a post corner to L. M. Carneal and James Meade; thence with the line of Meade and Carneal N 25° 42' W 363.0 ft., N 07° 19' W 194.5 ft., and N 68° 42' W 632.1 ft. to a post corner to Meade, Carneal and in the line of W. T. Markham; thence with the line of Markham and Meade N 25° 22' E 838.9 ft. to a post corner to same; thence crossing the land of Markham N 03° 09' E 264.1 ft. to a post, corner to same and T. J. Baker; thence with the line of Baker and Markham, and Robert Poe N 35° 40' W 1832.8 ft. to a rock corner to Poe in Markham's line; thence with the line of Markham, Poe and Engler N 40° 44' W 966.4 ft. to a Hickory in the line of Engler's farm purchased from Mary Anderson; thence severing the land of Engler N 29° 03' E 928.9 ft. to an oak, corner to Wayne Glasgow and Floyd Wilhelm in Engler's line; thence with the line of Glasgow and Wilhelm N 04° 05' E 1078.3 ft. to a stake in said line; thence severing the land of Wilhelm S 84° 30' E 1615.8 ft. to the beginning. Containing 220.91 acres.

A plat of the property is attached hereto and incorporated herein by reference as if fully copied herein and is marked Exhibit "A".

2. That this annexation is in the best interest of the welfare of the people within the present city limits boundaries of 'the City of Russellville, Kentucky, and is in the best interest of the people now owning property and/or residing and to be owning property and/or residing within the area proposed to be annexed.

- 3. That this annexation is for the following municipal purposes:
- a. To provide protection to the area proposed to be annexed.
- b. To provide, in the future, needed municipal services to the area proposed to be annex.
- c. To provide needed tax revenue to the City of Russell-ville, Logan County, Kentucky.
- 4. That the City Attorney of the City of Russellville, Logan County, Kentucky, is directed to take necessary steps for the completion of this annexation according to law, and in particular KRS 81.210, which reads as follows:

"Whenever a fourth-class city desires to annex any territory or to reduce the boundaries of the city, the city legislative body, shall by ordinance, accurately define the boundary of the territory proposed to be annexed or stricken off. The ordinance shall be published pursuant to KRS Ch. 242. Within thirty days after the adoption, publication and advertisement of the ordinance, a petition shall be filed in the circuit court of the county within which the city is situated, in the name and on behalf of the city, setting forth the passage, publication and advertisement of the ordinance and its object and purposes, together with an accurate description by metes and bounds of the territory proposed to be annexed or stricken from the city, and praying for a judgment to annex the territory or strike it from the city. Notice of the filing of the petition shall be given in the same manner as notice of passage of the ordinance. The circuit court shall not have jurisdicton of the proceedings unless the required publication or advertisement of the ordinance contains notice of the proposed proceedings in the court. If no defense is made within thirty (30) days after the filing of the petition and notice and the court makes no order for granting future time for making defense, the court shall render judgment annexing or striking off the proposed territory." (1976 ex s, \$ 15, § 74, eff. 1-2-78
