ORDINANCE NO. <u>81-1</u>

AN ORDINANCE REPEALING AN ORDINANCE PASSED BY THE CITY COUNCIL OF THE CITY OF RUSSELLVILLE, KENTUCKY, ON MAY 8, 1956, ENTITLED: "AN ORDINANCE DEFINING, CLASSIFYING AND REGULATING BUSINESSES, TRADES, OCCUPATIONS OR PROFESSIONS, OF (a) LABOR ORGANIZER AND PROMOTER, AND (b) LABOR SOLICITOR, WITHIN THE CITY OF RUSSELLVILLE, KENTUCKY; MAKING IT UNLAWFUL TO CONDUCT EITHER OF SAID BUSINESSES, TRADES, OCCUPATIONS OR PROFESSIONS WITHIN THE CITY OF RUSSELLVILLE, KENTUCKY, WITHOUT FIRST OBTAINING LICENSE; PRESCRIBING THE MANNER SUCH LICENSE MAY BE OBTAINED, THE AMOUNT OF LICENSE TAX HEREIN LEVIED, AND THE USE THEREOF; PROVIDING FOR THE FOR-FEITURE OF SAID LICENSE; PRESCRIBING PENALTIES FOR THE VIOLATION OF THE PROVISIONS OF THIS ORDINANCE; DECLARING THE PROVISIONS HEREOF SHALL BE SEVERABLE; AND REPEALING ANY CONFLICTING ORDINANCES OR PARTS THEREOF", AS AMENDED DECEMBER 4, 1956.

BE IT ORDAINED BY THE CITY OF RUSSELLVILLE that pursuant to a CONSENT DECREE to be entered in United States District Court, Western District of Kentucky at Bowling Green, Civil Action No. C 79-0045-BG approved by the City Council on January 20, 1981, an Ordinance passed by the City Council entitled: AN ORDINANCE DEFINING, CLASSIFYING AND REGULATING BUSINESSES, TRADES, OCCUPATIONS OR PROFESSIONS, OF (a) LABOR ORGANIZER AND PROMOTER, AND (b) LABOR SCLICITOR, WITHIN THE CITY OF RUSSELLVILLE, KENTUCKY; MAKING IT UNLAWFUL TO CONDUCT EITHER OF SAID BUSINESSES, TRADES, OCCUPATIONS OR PROFESSIONS WITHIN THE CITY OF RUSSELLVILLE, KENTUCKY, WITHOUT FIRST OBTAINING LICENSE; PRESCRIBING THE MANNER SUCH LICENSE MAY BE OBTAINED, THE AMOUNT OF LICENSE TAX HEREIN LEVIED, AND THE USE THEFEOF; PROVIDING FOR THE FOR-FEITURE OF SAID LICENSE; PRESCRIBING PENALITIES FOR THE VIOLATION OF THE PROVISIONS OF THIS ORDINANCE; DECLARING THE PROVISIONS HEREOF SHALL BE SEVERABLE; AND REPEALING ANY CONFLICTING ORDINANCES OR PARTS THEREOF as amended December 4, 1956, be and same are hereby repealed.
