ORDINANCE NO. 82-15

AN ORDINANCE PROVIDING FOR THE ASSESSMENT OF ALL REAL AND PERSONAL PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF RUSSELLVILLE SUBJECT TO TAXATION FOR CITY PURPOSES, LEVYING AN AD VALOREM TAX THEREON FOR CITY PURPOSES, AND STATING THE PURPOSE FOR WHICH THE TAX IS LEVIED, WITH SEVERABILITY AND REPEALER CLAUSES AND PROVIDING FOR THE EFFECTIVE DATE HEREOF.

Be It Ordained by the City of Russellville that:

- (1) The City of Russellville does hereby elect to use the annual county assessment for porperty situated within the corporate limits of the City of Russellville as of January 1, 1982, as a basis of the ad valorem tax herein levied.
- (2) That the City does hereby levy an ad valorem tax on all real property within the corporate limits of the City of Russellville that is subject to taxation for city purposes for the year 1982 at a rate of 15.6 cents per hundred dollar valuation.
- (3) That the City does hereby levy an ad valorem tax on all personal property within the corporate limits of the City of Russell-ville that is subject to taxation for city purposes for the year 1982 at a rate of 18.9 cents per hundred dollar valuation.
- (4) That the purpose for which said tax is levied is to produce revenue for the General Fund of the City of Russellville for valid municipal purposes.
- (5) If any clause, provision or section of this ordinance shall be ruled void or unenforceable by any court of competent jurisdiction, the remainder hereof is intended to be enacted and shall be in force and effect notwithstanding.
- (6) That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this ordinance are, to the extent of such conflict, hereby repealed.
- (7) That this ordinance shall be effective upon its passing and publication according to law.
