AN ORDINANCE ADOPTING THE CITY OF RUSSELLVILLE,
KENTUCKY, BUDGET FOR JANUARY 1, 1982, THROUGH JUNE 30, 1983,
BY ESTIMATING REVENUES AND RESOURCES AND APPROPRIATING FUNDS FOR THE OPERATION OF CITY GOVERNMENT AND REPEALING ALL PRIOR ORDINANCES OR PARTS THEREOF, TO THE EXTENT OF AMY CONFLICT, WITH AN EMERGENCY PROVISION SUSPENDING
THE REQUIREMENT OF SECOND READING AND PROVIDING FOR ITS EFFECTIVE DATE.

WHEREAS, a budget proposal and budget message have been submitted by the Mayor to the City Council, and WHEREAS, the City Council accepts the recommendation of the Mayor and adopts this Budget Ordinance;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF RUSSELLVILLE:

SECTION 1: That the budget from January 1, 1982, through June 30, 1983, shall be:
