

ORDINANCE NO. 83-5

AN ORDINANCE AMENDING ORDINANCE NO. 82-16 TO PROVIDE THAT IN THE EVENT MAINTENANCE HAS BEEN PAID ON A GRAVE SPACE, THE PURCHASE PRICE OF WHICH DID NOT INCLUDE PERPETUAL CARE, FOR FIVE OR MORE CONSECUTIVE YEARS IMMEDIATELY PRECEDING THE EFFECTIVE DATE OF THIS AMENDMENT THEN PERPETUAL CARE MAY BE OBTAINED FOR SUCH GRAVE SPACE BY PAYING TO THE CITY OF RUSSELLVILLE AMOUNTS SET OUT HEREIN WITH A REPEALER AND SEVERABILITY CLAUSE.

BE IT ORDAINED BY THE CITY OF RUSSELLVILLE THAT Ordinance No. 82-16, Section (1), be and same is hereby amended to provide as follows:

1. "(1) The price of grave spaces including perpetual care at Maple Grove Cemetery shall be:

1 Grave Space	\$100.00
1/2 Lot or 5 grave spaces	475.00
1 Lot or 10 grave spaces	950.00

In the event maintenance has been paid on a grave space, the purchase price of which did not include perpetual care, for 5 or more consecutive years immediately preceding the effective date of this amendment, then perpetual care may be obtained for such grave space by paying to the City of Russellville the following amounts:

<u>One or more grave spaces, but less than five</u>	<u>\$25.00 per grave space</u>
<u>Five-grave lots</u>	<u>\$100.00 each, plus \$25.00 per additional grave space, if any, but less than an additional lot</u>
<u>Ten-grave lots</u>	<u>\$200.00 each, plus \$25.00 per additional grave space, if any, but less than an additional lot</u>

2. All portions of any section of any ordinance or rule or regulation in conflict herewith are hereby repealed to the extent of that conflict only.

3. In the event any provision of this ordinance is invalid for any reason, such invalidity shall not affect the validity of any other provision.

This Ordinance shall be effective upon its passage and publication.
