## ORDINANCE NO. 84-15

AN ORDINANCE ASSESSING AND LEVYING A PROPERTY TAX ON MOTOR VEHICLES HAVING A SITUS IN THE CITY OF RUSSELLVILLE, KENTUCKY, WITH A PROVISION DESCRIBING AN EMERGENCY NECESSITATING THE SUSPENSION OF THE REQUIREMENTS OF SECOND READING AND PUBLICATION OF THIS ORDINANCE.

BE IT ORDAINED BY THE CITY OF RUSSELLVILLE, KENTUCKY, THAT:

SECTION 1: There is hereby levied an Ad Valorem Tax of Eighteen and Nine Tenths Cents (18.9 ¢) for every one hundred dollars (\$100.00) of the assessed valuation of motor vehicles having a taxable situs in the City of Russellville as of the first day of January 1985, and for each year thereafter as listed in the Tax Assessment Ledger compiled by the Property Valuation Administrator of Logan County.

SECTION 2.: All monies collected from the tax levied in this ordinance shall be paid into the General Fund of the City to be used for the payment of proper expenditures as determined by the City Council of the City of Russellville, Kentucky.

SECTION 3: In accordance with K.R.S. 132.487 and K.R.S. 134.800 the aforesaid tax shall be assessed under a Centralized tax system, and collected by the Clerk of Logan County. It is further provided that for the collection of this tax on behalf of the City of Russellville, the Clerk of the County shall be paid four percent (4%) of monies collected on vehicle taxes. Payment to the City by the Clerk shall be as governed by K.R.S. 134.815.

SECTION 4: If any part of this ordinance shall be declared invalid, such shall not affect the remainder of the ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: The City Council of the City of Russellville, by the affimative vote of at least two thirds (2/3) of its membership, as shown below, declares that an emergency exists and suspends the requirements of second reading and publication of this ordinance in order for this ordinance to become effective, the emergency being that K.R.S. 132.487, effective January 1, 1985, requires that all cities proposing to levy an Ad Valorem Tax upon motor vehicles shall submit to the Department of Revenue on or before October 1 of the year preceding the assessment date, the tax rate to be levied against valuations as of that assessment date, and the City of Russellville has only recently been provided the Department of Revenue form to provide that information so that in order to comply with that requirement before October 1, 1984, and avoid financial loss to the City by a delay in the passage of this ordinance, it is necessary that an emergency be declared to exist and that the requirements of second reading and publication of this ordinance in order for it to become effective be suspended.

This Ordinance shall be in full force and effect from and after its enactment.
