

ORDINANCE NO. 85-11

AN ORDINANCE AMENDING ORDINANCE NO. 83-6 PROVIDING THAT THE ALCOHOLIC BEVERAGE CONTROL ADMINISTRATOR FOR THE CITY OF RUSSELLVILLE, KENTUCKY, SHALL HAVE CERTAIN POWERS AND DUTIES; WITH REPEALER CLAUSE; WITH A SEVERABILITY CLAUSE; AND PROVIDING FOR THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE CITY OF RUSSELLVILLE THAT:

1. A new Subsection D be and it is hereby added to Section XIII. VIOLATIONS OF STATE OR FEDERAL LAW OR OF THIS ORDINANCE; REVOCATION AND SUSPENSION OF LICENSE which is as follows:

D. The City Administrator shall have the following powers and duties:

To hold hearings, subpoena witnesses, compel their attendance, administer oaths, examine any person under oath, and require the production of any books or papers relative to the inquiry, regardless of whether the witnesses are licensees.

2. All portions of any section of any ordinance or rule or regulation in conflict herewith are hereby repealed to the extent of that conflict only.

3. In the event any provision of this Ordinance is invalid for any reason, such invalidity shall not affect the validity of any other provision.

This ordinance shall be effective after its passage and publication according to law.
