ORDINANCE 86-5

AN ORDINANCE AMENDING ORDINANCE 84-4 BY ESTABLISHING FEES FOR THE ISSUANCE OF BUILDING PERMITS AND FOR THE APPROVAL OF APPLICATIONS INVOLVING PLANNING AND ZONING; WITH A SEVERABILITY CLAUSE AND A REPEALER CLAUSE; AND PROVIDING FOR THE EFFECTIVE DATE THEREOF.

Whereas, the City of Russellville, Kentucky, has previously adopted Ordinance 84-4 -- "AN ORDINANCE DIVIDING THE CITY OF RUSSELLVILLE AND AREAS WITHIN ITS JURISDICTION INTO ZONES, SETTING FORTH GOALS, OBJECTIVES, AUTHORITY, THE TITLE TO WHICH THE ORDINANCE MAY BE REFERRED, GUIDELINES FOR INTERPRETATION THEREOF, AND DEFINITIONS; DIVIDING THE CITY INTO DISTRICTS AND BOUNDARIES AND PROVIDING FOR THE ZONING OF ANNEXED LANDS; STATING GENERAL PROVISIONS APPLICABLE TO ZONING DISTRICTS; DESCRIBING THE ZONING DISTRICTS AND THE BASIC REQUIREMENTS: STATING PROVISIONS APPLICABLE TO MOBILE HOMES AND MOBILE HOME PARKS; STATING PROVISIONS APPLICABLE TO PLANNED DEVELOPMENTS; STATING PROVISIONS APPLICABLE TO ZONING ADMINISTRATION; PROVIDING FOR AMENDMENTS TO THIS ORDINANCE, AND PROVIDING FOR THE LEGAL STATUS OF THIS ORDINANCE WITH A SEVERABILITY CLAUSE AND A REPEALER CLAUSE PROVIDING FOR THE EFFECTIVE DATE AND RECORDING OF THIS ORDINANCE AND ALL AMENDMENTS THERETO" -- which created comprehensive rules involving planning and zoning, and

WHEREAS, the Logan Joint Cities-County Planning
Commission has approved the amendment of said Ordinance

by establishing fees for the issuance of building permits and for the approval of applications, and has so notified the City Council of Russellville, Kentucky; and

WHEREAS, the City Council of Russellville, Kentucky, has accepted this recommendation and wishes to so amend said Ordinance;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF RUSSELL-VILLE, KENTUCKY THAT:

- 1. A new section entitled "Article 10.-Fees" is hereby added to Ordinance 84-4 with said section reading as follows:
- 10.01. The Zoning Administrator shall charge and collect the following fees prior to the issuance of any building permit or prior to the approval of any application stated below:
