RUSSELLVILLE ORDINANCE NO. 88- 2 LEWISBURG ORDINANCE NO. 88- / AN ORDINANCE OF THE CITIES OF RUSSELLVILLE AND LEWISBURG, KENTUCKY ENACTED FOR THE PROTECTION OF THE WATERSHED AREA FOR THE MUNICIPAL WATER SOURCE FOR LEWISBURG/RUSSELLVILLE, AT IT RELATES TO SPA LAKE BE IT ORDAINED BY THE CITIES OF RUSSELLVILLE AND LEWISBURG, KENTUCKY: THAT WHEREAS, the Cities of Russellville and Lewisburg, Kentucky, wish to protect the integrity of their municipal water sources: NOW, THEREFORE, the Cities of Russellville and Lewisburg, Kentucky, do hereby ordain as follows: Section 1. In order to protect the integrity of the Watershed Area which contributes to the municipal water sources of the Cities of Lewisburg and Russellville, Kentucky, and for the protection of those persons using the said water souce, the following activities relating to Spa Lake are hereby prohibited: Swimming and other water contact sports, such as water A) skiing are prohibited. No boats with a motor, other than electric trolling motors, are to be permitted upon the Lake. Houseboats and other floating crafts with toilets are prohibited. The area surrounding the lake, consisting of 25 feet C) in width from the normal pool elevation, shall be kept free of all sources of potential contamination, including septic tanks, drain fields, barns, livestock, etc., that would result in a violation of the Kentucky Water Quality Regulations as are presently in effect or are (KAR Title 401, Chapter 5). hereinafter amended. Sewage treatment plant discharges into the said lake are prohibited. E) Industrial/Commerical Point Source Discharges, including those which require Kentucky Pollution Discharge Elimination System Waste Water Permits shall be prohibited within the Watershed, unless specifically approved by the state permitting process. All land which drains into the said lake shall be restricted from pesticide use that will contribute to lake water contamination, as established by the Kentucky Water Quality Regulations as are presently in effect or are hereinafter amended. (KAR Title 401, Chapter 5). "Pesticide " is defined pursuant to KRS 217B.040 Section 2. as: Any substance or mixture of substances intended to prevent, destroy, control, repel, attract or mitigate any pest;

- Any substance or mixture of substances intended to be used as a plant regulator, defoliant, or desiccant; and
- c) Any substance or mixture of substances intended to be used as a spray adjuvant.

Section 3. A violation of any of the above provisions shall result in a fine of not less than One Hundred Dollars (\$100.00), and shall not exceed the amount of Five Hundred Dollars (\$500.00), and/or a term not to exceed thirty (30) days in the Logan County Jail.

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect the remaining provisions of this Ordinance.

Section 5. To the extent any provisions of this Ordinance may be in conflict with any previously adopted ordinance, resolution, rule and/or regulation of the Cities of Lewisburg and Russellville, with respect to the operation and management of the said Municipal Water Source, the provisions of this Ordinance shall prevail.

Section 6. This Ordinance shall be in full force and effect upon its adoption, approval, attestation and publication as provided by law.
