## ORDINANCE NO. 88-4

AN ORDINANCE AMENDING ORDINANCE NO. 82-16 "AN ORDINANCE SETTING THE PRICE OF GRAVE SPACES INCLUDING PERPETUAL CARE, OF OPENING AND CLOSING GRAVES ON WEEKDAYS AND HOLIDAYS AND SATURDAYS AND SUNDAYS AND FOR MAINTENANCE ON SPACES FOR WHICH PERPETUAL CARE HAS NOT BEEN PAID IN MAPLE GROVE CEMETERY WITH A SEVERABILITY AND REPEALER CLAUSE AND PROVIDING FOR THE EFFECTIVE DATE HEREOF" BY ESTABLISHING A REVISED SCHEDULE OF PRICES FOR GRAVE SPACES IN MAPLE GROVE CEMETERY AND FEES FOR OPENING AND CLOSING GRAVES IN THE MUNICIPAL CEMETERIES; AND PROVIDING AN EFFECTIVE DATE, WITH A REPEALER CLAUSE AND A SEVERABILITY CLAUSE.

BE IT ORDAINED BY THE CITY OF RUSSELLVILLE, that:

WHEREAS, the City of Russellville has previously adopted a schedule of prices for grave spaces in Maple Grove Cemetery and a schedule of fees for opening and closing graves in the municipal cemeteries as set forth in ORDINANCE NO. 82-16 "AN ORDINANCE SETTING THE PRICE OF GRAVE SPACES INCLUDING PERPETUAL CARE, OF OPENING AND CLOSING GRAVES ON WEEKDAYS AND HOLIDAYS AND SATURDAYS AND SUNDAYS AND FOR MAINTENANCE ON SPACES FOR WHICH PERPETUAL CARE HAS NOT BEEN PAID IN MAPLE GROVE CEMETERY WITH A SEVERABILITY AND REPEALER CLAUSE AND PROVIDING FOR THE EFFECTIVE DATE HEREOF"; and the City has determined that an adjustment in these prices and fees should be made in order to properly provide for the maintenance and operation of same;

NOW THEREFORE, be it ordained as follows:

A) Sections 1 and 2 of ORDINANCE NO. 82-16 "AN ORDINANCE SETTING THE PRICE OF GRAVE SPACES INCLUDING PERPETUAL CARE, OF OPENING AND CLOSING GRAVES ON WEEKDAYS AND HOLIDAYS AND SATURDAYS AND SUNDAYS AND FOR MAINTENANCE ON SPACES FOR WHICH PERPETUAL CARE HAS NOT BEEN PAID IN MAPLE GROVE CEMETERY WITH A SEVERABILITY AND REPEALER CLAUSE AND PROVIDING FOR THE EFFECTIVE DATE HEREOF" shall be and are hereby amended so that they shall read as follows:

(1) The price of grave spaces including perpetual care at Maple Grove Cemetery shall be:

l Grave Space	\$ <del>100-00</del>	200.00
<sup>1</sup> / <sub>2</sub> Lot or 5 grave spaces	475-00	950.00
l Lot or 10 grave spaces	950-00	1900.00

(2) The price of opening and closing a grave shall be as follows:

Weekdays					\$ <del>150.00</del>	200.00
Holidays	and	Saturdays	and	Sundays	\$ <del>175-00</del>	250.00

(B) If any clause, provision or section of this ordinance shall be ruled void or unenforceable by any court of competent jurisdiction, the remainder hereof is intended to be enacted and shall be in force and effect notwithstanding.

(C) That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this ordinance are, to the extent of such conflict, hereby repealed.

(D) That this ordinance shall be effective upon its passing and publication according to law.
