## ORDINANCE 88-8

AN ORDINANCE AMENDING ORDINANCE NO. 82-8 "AN ORDINANCE ADOPTING A CODIFICATION OF PERSONNEL CLASSIFICATION PLAN AND CODIFICATION OF PERSONNEL PAY PLAN, PROVIDING FOR WAIVER THEREOF, REPEALING PRIOR CONFLICTING ORDINANCES AND REGULATIONS, WITH SEVERABILITY CLAUSE AND EMERGENCY PROVISION" BY MODIFYING CERTAIN PROVISIONS OF THE PERSONNEL PAY PLAN AND THE PERSONNEL CLASSIFICATION PLAN; WITH SEVERABILITY AND REPEALER CLAUSES; AND PROVIDING FOR AN EFFECTIVE DATE.

THAT WHEREAS, the City of Russellville, Kentucky has previously adopted a Codification of the Personnel Pay Plan and a Codification of the Personnel Classification Plan by Ordinance No. 82-8, that was subsequently amended by Ordinance No. 87-1, and the city representatives desire to modify certain provisions of same;

NOW, THEREFORE, BE IT ORDAINED THAT:

- I. Section I of Ordinance No. 82-8 as amended is hereby amended so that it shall read as follows:
- (1) The Codification of Personnel Classification Plan dated April 6, 1982, and Codification of Personnel Plan dated April 6, 1982, attached hereto are hereby adopted for the City of Russellville and are incorporated herein by reference and made a part of the permanent records of the City. The Pay Plan and Longevity Schedule, the Grade Allocation, and the Position Description for Director of Finance, Water/Sewer Maintenance Coordinator, Street Supervisor, and City Engineer, that were originally attached and adopted with these plans are hereby repealed and are replaced with the Pay Plan and Longevity Schedule (Rev. 7-8-86 8-1-88, the Grade Allocation and the Position Description for Office Manager, Utilities Superintendent, Assistant Utilities Superintendent, Street Supervisor and Assistant Parks Director that are attached hereto and incorporated herein by reference and make a part of the permanent records of the City. Section C (4) (a) of the Codification of Personnel Pay Plan is amended to provide that progression from Step A to Step B shall occur after one year of service, subject to the other terms and conditions of the plan.
- II. In the event any provision of this Ordinance is invalid for any reason, such invalidity shall not affect validity of any other provision.
- III. All portions of any section of any ordinance or rule or regulation in conflict herewith are hereby repealed to the extent of the conflict only.

IV. This Ordinance shall be effective upon its passage and publication according to law.
