ORDINANCE NO. 95- 17

AN ORDINANCE AMENDING ORDINANCE NO. 91-4 "AN ORDINANCE ESTABLISHING A REVISED SCHEDULE OF RATES AND CHARGES FOR THE USE OF AND SERVICES RENDERED BY THE WATER WORKS SYSTEM AND SEWER SYSTEM OF THE CITY OF RUSSELLVILLE, KENTUCKY, AND REPEALING ALL PORTIONS OF ANY PRIOR ORDINANCES IN CONFLICT HEREWITH TO THE EXTENT OF THAT CONFLICT ONLY, WITH SEVERABILITY CLAUSE"; WITH CERTAIN TECHNICAL CORRECTIONS AND RATE CHANGES: AND WITH REPEALER AND SEVERABILITY CLAUSES; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, the City of Russellville, Kentucky, has previously enacted Ordinance 91-4, "AN ORDINANCE ESTABLISHING A REVISED SCHEDULE OF RATES AND CHARGES FOR THE USE OF AND SERVICES RENDERED BY THE WATER WORKS SYSTEM AND SEWER SYSTEM OF THE CITY OF RUSSELLVILLE, KENTUCKY, AND REPEALING ALL PORTIONS OF ANY PRIOR ORDINANCES IN CONFLICT HEREWITH TO THE EXTENT OF THAT CONFLICT ONLY, WITH SEVERABILITY CLAUSE", and

WHEREAS, the City has determined the need to amend said ordinance to make certain technical corrections and rate changes,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF RUSSELLVILLE that said ordinance is hereby amended as follows:

- A) Section I of that Ordinances hereby changed so that the following numbered paragraphs of that Section shall read as follows:
 - (1) Installation of water meters service

\$150 for 5/8 inch meter

-200 for 1 inch meter

300 for 1-1/2 inch meter

500 for 2 inch meter

A fee of Three Hundred Dollars (\$300.00) shall be charged for installation of 5/8 inch through 1-1/2 inch meters by the city to offset the cost of its labor, and the city shall also charge a fee equal to the actual cost of the meter and parts being installed. Applicants for water service using meters equal to or greater than two (2) inches shall be responsible for all costs of installation, including the costs of labor and equipment, with the city being furnished with adequate notice and plans for this installation so that the city can monitor the installation. The actual placement of the meter and the pit must be approved by the city prior to their installation. Upon completion of the installation, all of the equipment installed shall become the property of the city. An

inspection fee of One Hundred Dollars (100.00) shall be paid to the city prior to the commencement of any installation.

- (3) Connection or tap of sewer lines: \$75.00 Three Hundred Dollars (\$300.00) per connection
- B) All portions of any section of any ordinance or rule or regulation in conflict herewith are hereby repealed to the extent of that conflict only.
- C) In the event any portion of this Ordinance is invalid for any reason, such invalidity shall not affect the validity of any other provision.
- D) This ordinance shall be effective upon its passage and publication according to law with the provision that the revised rates shall not apply to applications for service made by property owners during the next nine months in connection with all presently ongoing sewer line extensions that will be constructed by the City that will create a mandatory sewer connection for those citizens.
