ORDINANCE 97-12

AN ORDINANCE AMENDING ORDINANCE 97-2 AND REPEALING ORDINANCE 97-2; WITH REPEALER AND SEVERABILITY CLAUSES AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, the City of Russellville, Kentucky, has previously enacted Ordinance 97-2, which established rates for sewer use charges,

AND, WHEREAS, the City has determined that the rates need to be revised to reflect the future costs of operating the system;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF RUSSELLVILLE THAT

1. Article IV, Section 1 of Ordinance 97-2 is hereby amended so that it shall read as

follows:

Section 1: The following schedule of user charge rates shall apply to each user of

the wastewater treatment works. This schedule includes rates for OM&R and rates for debt

service charges, each based on the volume of metered or estimated water consumption:
