ORDINANCE 98- 18

AN ORDINANCE DESIGNATING CERTAIN ROUTES AS "NO THROUGH TRUCK TRAFFIC" ROUTES; AUTHORIZING THE ERECTION OF SIGNS AND MARKINGS; PROVIDING FOR PENALTIES AND AN EFFECTIVE DATE; AND WITH A SEVERABILITY AND REPEALER CLAUSE

WHEREAS, the City Council of the City of Russellville has determined that designating routes as "No Through Truck Traffic" routes would be in the best interest of the City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF RUSSELLVILLE, KENTUCKY:

Section I: No truck shall travel on any street or on any portion of any street which is designated by the street supervisor, subject to approval by the council, as being prohibited to through trucks and is properly signed in accordance with that designation. This prohibition shall not apply to trucks which have a destination on the designated street or on the designated portion of any street, noncommercial vehicles, vans, step-vans, recreational vehicles, pickup trucks, or trucks which are owned or operated by the city.

Section II: The highways or portions thereof marked on Exhibit "A" as attached hereto and incorporated herein by reference are hereby designated as the truck routes for through truck traffic, and no truck without a local destination shall use any other route except as necessary to gain ingress or egress to the truck route.

Section III: The Department of Highways for the State of Kentucky shall be contacted by the appropriate city officials to prepare and have erected proper signs or markings as will clearly mark the truck routes as herein designated.

Section IV: In the event any provision of this Ordinance is invalid for any reason, such invalidity shall not affect the validity of any other provision.

Section V: All portions of any section of any ordinance or rule or regulation in conflict herein are hereby repealed to the extent of that conflict only. Ordinance 88-9 is specifically repealed.

Section VI: Whoever violates any provision of this ordinance shall be guilty of a misdemeanor and may be punished by a fine of not less than \$50.00 and not more that \$500.00, or imprisonment of not more than thirty (30) days in jail, or by both fine and imprisonment.

Section VII: This Ordinance shall be effective upon its passage and publication according to law.
