

ORDINANCE NO. 98- 22

AN ORDINANCE PROVIDING FOR THE ADOPTION, BY REFERENCE, OF THE KENTUCKY BUILDING CODE AS PROMULGATED IN 815 KAR 7:015 BY THE BOARD OF HOUSING AND CONSTRUCTION, COMMONWEALTH OF KENTUCKY, TOGETHER WITH ALL AMENDMENTS THERETO AND REGULATIONS OF SAME; PROVIDING FOR PENALTIES AND FEES; PROVIDING FOR A SEVERABILITY AND REPEALER CLAUSE AND PROVIDING FOR AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY OF RUSSELLVILLE, KENTUCKY, that:

**SECTION I. SCOPE.** This ordinance shall apply to every building or structure or appurtenances connected or attached to such buildings or structures within the city limits of Russellville, Kentucky.

**SECTION II. ADOPTION.** The City hereby adopts and incorporates by reference as if produced herein in full, the Kentucky Building Code as promulgated in 815 KAR 7:015 by the Board of Housing, Buildings and Construction, Commonwealth of Kentucky, and all amendments thereto and regulations promulgated thereby. A copy of the Code is filed in the office of the City Clerk.

**SECTION III. PENALTIES.** Any person who shall violate any provision of this Code or any directive or order issued pursuant thereto shall, upon conviction thereof, be subject to a fine of not less than fifty (\$50.00) dollars nor more than three hundred (\$300.00) dollars or imprisonment for a term not to exceed ninety (90) days, or both, at the discretion of the court. Each day that a violation continues after due notice has been served, in accordance with the terms and provisions hereof, shall be deemed a separate offense.

**SECTION IV. ENFORCEMENT OFFICER**

The Zoning Administrator/Building Inspector is designated as the local enforcement officer for this Code.

**SECTION V. FEES.**

The fees for permits and inspections shall be as provided for in the attached schedule.

**SECTION VI. REPEALER CLAUSE.** All portions of any section of any ordinance or rule or regulation in conflict herewith are hereby repealed to the extent of that conflict only.

**SECTION VII. SEVERABILITY CLAUSE.** In the event any provision of this ordinance is invalid for any reason, such invalidity shall not affect the validity of any other provision.

**SECTION VIII. EFFECTIVE DATE.** This Ordinance shall be effective after its passage and publication according to law.
