

ORDINANCE NO. 99-7

AN ORDINANCE AMENDING ORDINANCE NO. 89-8 "AN ORDINANCE ADOPTING THE NATIONAL ELECTRIC CODE; PROVIDING FOR THE APPOINTMENT OF AN ELECTRICAL INSPECTOR; SPECIFYING THE QUALIFICATIONS AND DUTIES OF AN ELECTRICAL INSPECTOR; REQUIRING PERMITS FOR COMMENCING CONSTRUCTION, ALTERATIONS OR REPAIRS OF ANY ELECTRICAL WIRING AND PRESCRIBING FEES THEREFOR; AUTHORIZING ADOPTION AND AMENDMENT OF REGULATIONS IMPLEMENTING THIS ORDINANCE, AND PRESCRIBING PENALTIES FOR THE VIOLATION HEREOF." BY ENACTING A NEW FEE SCHEDULE AND PROVIDING AN EFFECTIVE DATE; WITH A SEVERABILITY CLAUSE AND A REPEALER CLAUSE

WHEREAS, the City of Russellville has previously enacted Ordinance No. 89-8 "An Ordinance Adopting the National Electrical Code; Providing for the Appointment of an Electrical Inspector; Specifying the Qualifications and Duties of an Electrical Inspector; Requiring Permits for Commencing Construction, Alterations or Repairs of any Electrical Wiring and Prescribing Fees Therefor; Authorizing Adoption and Amendment of Regulations Implementing this Ordinance, and Prescribing Penalties for the Violation Hereof." and the City has determined that an adjustment of the fees is necessary,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF RUSSELLVILLE, KENTUCKY, THAT:

1. The four (4) numbered parts of Section IV of Ordinance 89-8 shall be and are hereby amended so that they shall read as follows:

1. Single Phase Farm, Residential, and Small Commercial

a.	Meter poles and service entrance		\$35.00
b.	Up to 100-amp service with branch circuits	\$30.00	\$60.00
c.	200-amp service with branch circuits	\$40.00	\$80.00
d.	300-amp service with branch circuits	\$50.00	\$90.00
e.	400-amp service with branch circuits	\$60.00	\$100.00
f.	600-amp service with branch circuits	\$85.00	\$120.00

2. Three-Phase Commercial and Industrial

a.	Up to 100-amp service with branch circuits	\$40.00	\$70.00
b.	200-amp service with branch circuits	\$55.00	\$90.00
c.	400-amp service with branch circuits	\$80.00	\$110.00
d.	600-amp service with branch circuits	\$90.00	\$130.00
e.	800-amp service with branch circuits	\$100.00	\$140.00

f.	1,000-amp service with branch circuits	\$110.00	\$160.00
g.	2,000-amp service with branch circuits	\$220.00	\$300.00
h.	3,000-amp service with branch circuits	\$330.00	\$400.00
3.	Re-inspection for all of the above	\$25.00	\$35.00
4.	Entrance Change and Rough-ins <u>and Extra Trips</u>	\$20.00	\$35.00 per trip plus \$.05 \$.10 per amp over 400

II. In the event any portion or portions of this Ordinance are declared invalid for any reason, such invalidity shall not affect the validity of the other portions hereof, and the other portions hereof shall remain in full force and effect.

III. All prior Ordinance and/or regulations of the City of Russellville in conflict with the provisions of this Ordinance are hereby repealed to the extent of that conflict only, and such ordinances and/or regulations to the extent of that conflict shall cease to be effective upon the effective date of this Ordinance.

IV. This Ordinance shall become effective upon its passage and publication according to law.
