CITY OF RUSSELLVILLE, KENTUCKY ORDINANCE 2011-09

AN ORDINANCE CLOSING A PORTION OF WEST FOURTH STREET AND EXCHANGING IT FOR A RIGHT OF WAY DEDICATION FROM FIRST SOUTHERN NATIONAL BANK

WHEREAS, the City of Russellville, Kentucky, accepted an addition to the boundaries of the City known as the Curd Addition as shown in Deed Book E page 36, which included an extension of Fourth Street in a westerly direction from it's intersection with Bethel Street;

AND WHEREAS, the City of Russellville, Kentucky, and First Southern National Bank have reached an agreement to close a portion of West Fourth Street in exchange for the dedication of a new right of way;

WHEREAS, First Southern National Bank is the adjoining owner of all sections of the West Fourth Street that is to be closed; and

WHEREAS, The City Council in and for the City of Russellville, Kentucky, deems it appropriate for the health, safety and welfare of its citizens to close the aforementioned portion of the street, and for the land to revert to First Southern National Bank as the adjoining land owner and to accept the hereafter described property as a dedicated right of way;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RUSSELLVILLE, KENTUCKY, THAT:
