**AN ORDINANCE AMENDING ORDINANCE 2000-02 TO REDUCE THE NUMBER OF MEMBERS COMPRISING THE CODE ENFORCEMENT BOARD**

---

WHEREAS, on February 8, 2000, the Russellville City Council passed Ordinance 2000-02, which created a Code Enforcement Board; and

WHEREAS, upon recommendation of the Code Enforcement, the City Council desires to reduce the number of members comprising the Code Enforcement Board from seven to five members; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL IN AND FOR THE CITY OF RUSSELLVILLE, KENTUCKY AS FOLLOWS:

**SECTION A: SUBSTANTIVE AMENDMENTS**

I) Ordinance 2000-02, "SECTION 2. Creation and Membership." is amended to read as follows:

There is hereby created pursuant to KRS 65.8801 to KRS 65.8839 within the city, a code enforcement board which shall be composed of ~~seven~~ five members, all of whom shall be residents of the city for a period of at least one (1) year prior to the respective member's appointment ~~creation of the board~~ and shall reside there throughout the term in office.

II) Ordinance 2000-02, "SECTION 4. Appointment of members; terms of office; removal from office; oath; and compensation." is amended to read as follows:

h. Following the initial appointment of the code enforcement board and the expiration of the respective initial terms, the term for each subsequent appointment shall be one (1) year.

**SECTION B: SEVERABILITY CLAUSE**

In the event any provision of this Ordinance is invalid for any reason, such invalidity shall not affect any other provision.

**SECTION C: REPEALER CLAUSE**

All portions of any ordinance or rule or regulation in conflict herewith are hereby repealed to the extent of that conflict only.


**SECTION D: EFFECTIVE DATE**

This Ordinance shall be effective upon its passage and publication according to law.

**FIRST READING** conducted on the 21st day of August 2012.

**SECOND READING** conducted and **PASSAGE** on the 4th day of September 2012.
