

**CITY OF RUSSELLVILLE, KENTUCKY  
ORDINANCE NO. 2015-03**

**AN ORDINANCE ADOPTING AND ENACTING A NEW CODE OF ORDINANCES  
FOR THE CITY OF RUSSELLVILLE, KENTUCKY**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RUSSELLVILLE,  
KENTUCKY:**

**SECTION 1.** That the Code of Ordinances, consisting of Chapters 10 through 154, and Tables I through IX, each inclusive, be and is hereby adopted and enacted as the "Code of Ordinances of Russellville, Kentucky," and shall be treated and considered as a new and original comprehensive ordinance which shall supersede all other general and permanent ordinances of the city passed on or before September 9, 2014, to the extent provided in Section 2 hereof.

**SECTION 2.** That all provisions of such Code shall be in full force and effect from and after September 9, 2014, and all ordinances of a general and permanent nature of the City of Russellville, enacted on final passage on or before the September 9, 2014, and not included in such Code or recognized and continued in force by reference therein are hereby repealed from and after September 9, 2014, except as hereinafter provided.

**SECTION 3.** That the repeal provided for in Section 2 hereof shall not affect the following:


- (A) Any offense or act committed or done or any penalty or forfeiture incurred or any contract or right established or accruing before the effective date of this ordinance;
- (B) Any ordinance promising or guaranteeing the payment of money for the City, or authorizing the issuance of any bonds of the City or any evidence of the City's indebtedness, or any contract or obligation assumed by the City;
- (C) Any ordinance authorizing the execution of agreements with other governments or agencies;
- (D) Any ordinance fixing salaries of officers or employees of the City;
- (E) Any appropriation ordinance;
- (F) Any right of franchise granted to any person, firm, or corporation;
- (G) Any ordinance dedicating, naming, establishing, locating, relocating, opening, closing, paving, widening, vacating, etc., any street or public way on the City;

- (H) Any ordinance establishing any official position of the City which is not specifically referred to in the Code;
- (I) Any ordinance providing for local improvements or assessing taxes therefor;
- (J) Any ordinance dedicating or accepting any plat or subdivision in the City, or providing regulations for same;
- (K) Any ordinance annexing property to the City;
- (L) Any zoning ordinance or amendment thereto, except as inconsistent with the said code provisions;
- (M) Any subdivision ordinance or amendment thereto;
- (N) Any taxation ordinance;
- (O) Any ordinance prescribing traffic regulations for specific locations, prescribing through streets, parking limitations, parking prohibitions, one way traffic, limitations on loads of vehicles or loading zones, or dealing with parking meters, parking meter zones or flow of traffic generally, not inconsistent with such Code;
- (P) Any ordinance dealing with the electric, water, sewer, or sewage disposal utilities of the City of fixing charges for use of such facilities;
- (Q) Any ordinance enacted after September 9, 2014; AND
- (R) Such repeal shall not be construed to revive any ordinance or part of an ordinance which is repealed by this ordinance.



In accordance with KRS 86A.060(9), the undersigned, a licensed, practicing attorney in the Commonwealth of Kentucky, summarizes this Ordinance as follows:

- 1) The Russellville City Council adopted and enacted the "Code of Ordinances of Russellville, Kentucky," consisting of Chapters 10 through 154, and Tables I through IX, each inclusive, and the same shall be treated and considered as a new and original comprehensive ordinance which shall supersede all other general and permanent ordinances of the city passed on or before September 9, 2014.
- 2) Said Code repeals certain ordinances not otherwise provided for therein and provides a list of the types of actions and ordinances that are not repealed, including but not limited to ordinances passed after September 9, 2014.

The City Council of Russellville, Kentucky adopted this Ordinance after a first reading conducted on August 4, 2015, and a second reading conducted on August 18, 2015.
