ORDINANCE 2015-06

AN ORDINANCE AMENDING ORDINANCE NO. 99-13, RUSSELLVILLE ARTS AND HUMANITIES COUNCIL, BY AMENDING ARTICLE II, SECTION 4 TO INCREASE THE NUMBER OF VOTING MEMBERS

WHEREAS, Ordinance 99-13 was amended by Ordinance 2007-04 and Ordinance 2012-12; AND

WHEREAS, the City Council of Russellville, Kentucky deems it appropriate and necessary to make certain changes to the composition of the Russellville Arts and Humanities Council;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of Russellville, Kentucky that:

SECTION I. SUBSTANTIVE AMENDMENTS. Article II, Section 4 is hereby amended as follows:

- (a) The membership of the Arts Council shall consist of ~~five (5)~~ seven (7) ~~Commissioners~~ members, one of whom shall be a council representative, who and shall all be appointed by the Mayor, with the approval of the City Council.
- (b) An Arts Council member shall serve without compensation. When a vacancy occurs in said Council, by means of resignation, death, removal from the community or removal for failure to perform the duties of an Arts Council member, the vacancy will be filled for the unexpired term in the manner provided for original appointments. The terms of ~~Commissioners~~ members shall be for a period of one (1) year, ending on December 31 of each year following the initial appointment. The term of each subsequent shall be for one (1) year.
- (c) The ~~Commission~~ Arts Council shall, at its first meeting in January of each year select, or re-appoint, a Chairperson and a Vice Chairperson. The ~~Commission~~ Arts Council may also select up to six (6) at-large members with a non-voting status.

SECTION II. SEVERABILITY. The provisions of this Ordinance are severable. If any sentence, clause, or part of this Ordinance or the application thereof to any particular state of case is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or repeal any of the remaining provisions, sentences, clauses or sections or parts of this Ordinance, it being the legislative intent of this body to ordain and in act each other.


SECTION III. REPEAL OF EXISTING ORDINANCES. All ordinances or parts of ordinances in conflict herewith now in effect, to the extent of said conflict, are hereby repealed.

SECTION IV. EFFECTIVE DATE. This ordinance shall become effective upon passage and publication as required by law.


