The Building Inspector may at any time before or during the demolition, require a phase one environmental study from a certified agency to access, test and remove any harmful product found in the building. The Building Inspector may at any time, issue a STOP WORK ORDER for the project until the study is complete and all suspected material is removed and a written report is shall originate from a certified agency attesting to the abatement of the project.

The demolition of any building is not considered complete until the lot is in a serviceable or buildable condition. On lots where fill is required, the lot must be filled to a level condition and sown with grass and rye or the lot may be overlaid with gravel as a parking lot.

The Demolition Contractor shall be granted one day for each 500 square feet of building space in which to start and finish the completed demolition of each building once the demolition begins. Should the time limit expire, the Demolition Contractor and the Property Owner shall incur a fine of (\$100.00) one hundred dollars per day for each day past the proposed time line and shall be jointly and severally liable for the same.

Notification to all utilities must be made for disconnection to the property before the demolition begins.

The contractor shall provide information regarding material type(s) being handled and/or removed from the site and the location at which the material will be disposed of. Material requiring special permitting from other agencies, shall have the appropriate documentation attached to this application.
